TO: ALL CALIFORNIA LAW ENFORCEMENT AGENCIES

The purpose of this bulletin is to inform all law enforcement agencies that the California Department of Justice (DOJ), is updating the California Restraining and Protective Order System (CARPOS). Pursuant to the National Crime Information Center (NCIC) Extreme Risk Protection Order File (ERPOF) Policy 1.2, DOJ will only forward gun violence restraining orders requested by a law enforcement officer to the NCIC ERPOF. Therefore, a gun violence restraining order requested by other types of petitioners (non-law enforcement officers) will not be forwarded to the NCIC. All records forwarded to the ERPOF will programmatically add the below verbiage to identify other than firearms the complete list of prohibited items to the Miscellaneous (MIS) field as required by NCIC.

ADDITIONAL PROHIBITIONS-RECEIVERS, FRAMES, FIREARM PRECURSOR PARTS, AMMUNITION, MAGAZINES, CONTACT AGENCY FOR TERMS-

MIS field data entered in CARPOS by the user will be appended after the programmatic ERPOF MIS verbiage. For example, if the user enters in the MIS field in CARPOS, "Officer Example requested emergency order for Example Respondent," the verbiage will display in each system as follows.

CARPOS: MIS/OFFICER EXAMPLE REQUESTED EMERGENCY ORDER FOR EXAMPLE RESPONDENT

ERPOF: MIS/ADDITIONAL PROHIBITIONS-RECEIVERS, FRAMES, FIREARM PRECURSOR PARTS, AMMUNITION, MAGAZINES, CONTACT AGENCY FOR TERMS-OFFICER EXAMPLE REQUESTED EMERGENCY ORDER FOR EXAMPLE RESPONDENT

If the MIS field data for the ERPOF exceeds 500 characters, only the first 500 characters will be forwarded.

No programming changes will be required.
